8 Sustainability Oversight in Group

The implementation and execution of the Sustainability & ESG Policy is a cross-cutting commitment throughout the Group, with all departments responsible for gradually integrating it into their strategic and operational agendas.

Among its duties, the Sustainability & ESG Directorate monitors sustainability initiatives and evaluates and proposes to the relevant body the adoption of new initiatives that are relevant to Altia Group within this scope.

Additionally, the Sustainability & ESG Directorate is tasked with overseeing the implementation of this Policy within its areas of responsibility.

8.2 Update of the Sustainability & ESG Policy

The Policy will be subject to review as it is necessary to align it with legal changes and/or to incorporate the best practices deemed necessary to achieve its objectives.

8.3 Communication and Dissemination of the Sustainability & ESG Policy

The communication of sustainability practices will be carried out annually in the Sustainability Report and the non-financial information report, allowing stakeholders to evaluate Altia Group's performance in this area during the relevant fiscal year.
